Terms and Conditions

- Only current members are eligible to rent a campsite.
- The hold site deposit must be paid by November 30th.
- If you cancel after January first the deposit will be forfeit.
- Campers are responsible for any damages caused by themselves or their guests.
- Campers will clean their site of trash, disposing of it in the dumpster daily.
- No campfires are to be left unattended.
- Campers agree to help keep the bathrooms and shower room clean.
- Sewage tanks may be dumped only between 8am and 6pm but not while there is a function at the Lodge.
- One outside refrigerator is allowed, if it is not an eyesore, and no larger than 4.5 cu.ft.
- Addition or expansion of campsite decks must be approved by the Caretaker.

KCF&G Will Provide

- Running water from April 1 through Columbus Day Weekend (weather permitting).
- Electric service from April 1 until the end of October.
- WiFi available at the lodge and campers are welcome to access it on the screened-in porch whenever the lodge is not being rented.
- Bathrooms located in the lodge—access via ramp and a door next to the road.
- The campers' shower room located on the Beach side of the lodge.
- A picnic table for each campsite.
- 8 cinder blocks for campfire surrounds for each campsite and replace them as needed.
- Speed bumps to protect campers and children from thoughtless drivers.

Campground Rules

- **Illegal drug use will not be tolerated on KCF&G property.**
- Minors must be accompanied by a parent or guardian.
- No fireworks are permitted.

Dogs

- Dangerous dogs, regardless of breed, are not allowed on KCF&G property.
- No more than 3 dogs are permitted per campsite.
- Pets must be leashed at all times on KCF&G property.
- Barking for more than 15 minutes is considered excessive, is not acceptable, and can result in the camper’s removal if not addressed promptly.
- Clean up after pets and dispose of waste properly.

Guest & Parties

- Be respectful of other campers by keeping the noise down.
- Each campsite is permitted to have 4 guests, for whom the registered camper is responsible. **Everyone** must adhere to campground and Beach rules.
- Inappropriate behavior and unruly conduct will not be tolerated and offenders will be asked to leave the property. If a request to leave is ignored the Knox County Sheriff’s Department will be called for removal of the offending individual(s).*
- There will be no refund of camping fees if campers are ejected from the campground for violating these rules.
- All parties must be over by 11:00 PM.
- All guests will leave before midnight if not staying the night.

*Should a member be removed, he or she will be banned from KCF&G property until a decision on appropriate action is made by the Board of Directors. This could lead to loss of membership and camping privileges.
