The Club shall not be liable for, and Undersigned, on behalf of his/her executors, personal representatives, administrators, assignees, heirs and next of kin, hereby expressly releases The Club from any and all such claims and liabilities.

Undersigned hereby expressly assumes the risk of taking part in the course of instruction in firearms and taking part in the activities on The Premises, which include but are not limited to, instruction in the use of firearms, firearms competition, the discharge of firearms and the firing of live ammunition. Undersigned hereby acknowledges and agrees that Undersigned furthermore hereby understands its terms and is executing this instrument voluntarily. Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands, and will abide at all times by all range rules and procedures and any other rules and procedures stated by The Club.

Undersigned expressly agrees that this instrument is intended to be as broad and inclusive as permitted by law, and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder by The Club shall not constitute any waiver of the Club's right to pursue other available remedies. This instrument binds Undersigned and his/her executors, personal representatives, administrators assignees, heirs and next of kin.
